Richmond lies 8 miles south west of central London with excellent communication links. Its station has regular direct services to London Waterloo (19 minutes). The A307 runs through Richmond leading to Junction 10 of the M25 via the A3. The A316 links to the M3 motorway and onto the M25. The M4 is 2.5 miles to the north.

Richmond Brewery Stores occupies a prominent position on the east side of Petersham Rd/A307- Richmond's main arterial road. The building was built in 1882 as a bottling factory and has undergone significant redevelopment to provide contemporary warehouse style office space arranged over ground and first floors.
