Location:

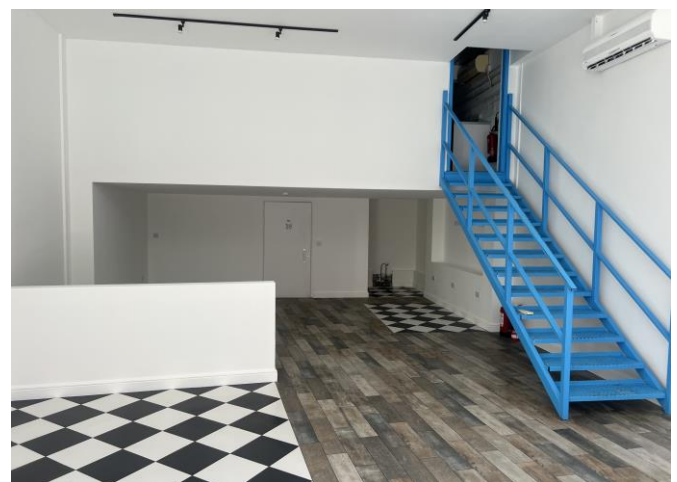
