The building has outstanding views overlooking The River Thames with a large terrace. The property offers an occupier the opportunity of giving staff a tranquil working environment.



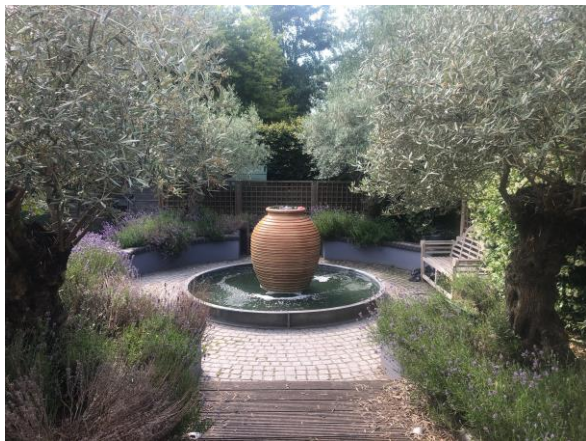
