#### Location:

Eel Pie Island is situated on the River Thames close to Twickenham town centre. The River Room, Phoenix Wharf is located on the north side of the island with access via a footbridge from The Embankment. The island has a unique and historical background and provides a special environment.

Eel Pie Island is a short distance from Twickenham Main Line Station providing regular fast links to London Waterloo and out of London. It is also convenient for M3, M4 and M25 motorways and within 20 minutes of Heathrow Airport. The shopping facilities of Twickenham town centre are within a two minute walk.









# **Description:**

Phoenix Wharf is a complex of 12 creative studios and 3 houseboats. There is a range of six lower deck studios and six upper deck studios. There are toilets for visitors and staff use and all studios are fitted with broadband. The building has outstanding views overlooking The River Thames.
