The Churchill Business Park offers Industrial and warehouse accommodation within a well landscaped estate .This mid terraced unit is of brick construction under a shallow pitched steel trussed roof. The ground floor warehouse with a loading door is accessed from the loading yard. The offices are separately entered from the front reception. The first floor offices have good natural lighting and an open plan fully fitted configuration with 13 amp power distribution lighting, suspended ceiling and partial air-conditioned electric heating.

Churchill Business Park, is situated on Hortons Way to the north of the A25 and Westerham town centre. The Sevenoaks junction (jct 5) of the M25 to the east provides excellent access to the national motorway network. The estate is roughly equidistant between Jct 5 and 6 of the M25 Sevenoaks and Godstone .

Sevenoaks railway station is to the east, provides regular National Rail services to Central London (London Bridge & Charing Cross - 30 minutes), and the South Coast.

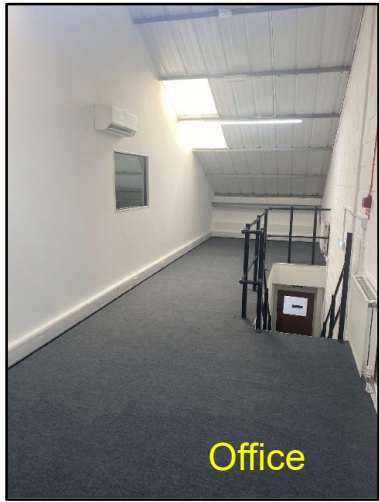

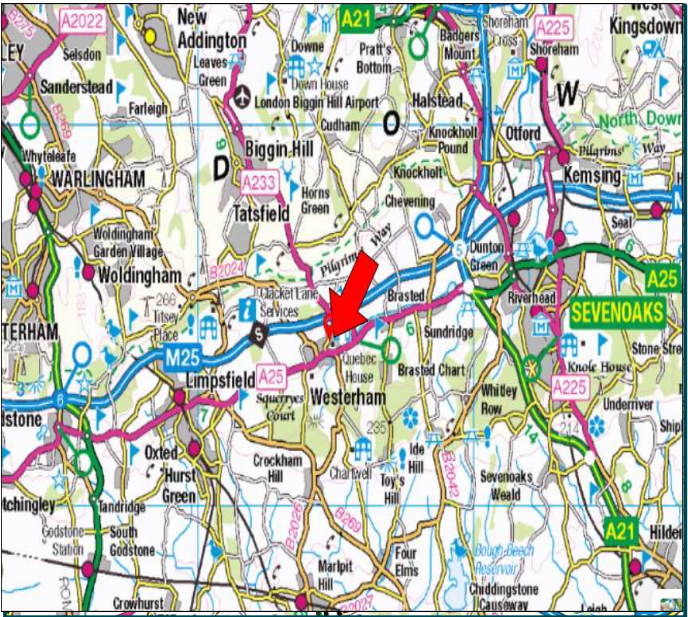
